DECRETA

Art. 1 – Implementation

With the aim of promoting the internationalization of its 28th Cycle Doctoral Programme, the University of Messina, Italy, will fund ten places (Euros 12378.27 net *per annum*) reserved for foreign citizens from countries outside the European Union, interested in attending any of the courses listed in annexes A1 and A2.

Candidates will be evaluated on the basis of their academic and professional qualifications.

Four out of ten places are reserved for Tunisian and/or Moroccan citizens, and two places for Chinese citizens, all entitled with appropriate academic and professional qualifications. In case the six places are not allocated to Chinese, Moroccan and/or Tunisian citizens, they will be assigned to the other eligible candidates in the final list.

Courses last three years and will commence on January 2013.

Art. 2 – Admission Requirements

Applicants are required to meet the following criteria in order to be eligible:

- to be citizens of a non-EU country;
- to hold a university degree (min. 4 year course) or a specialist/master's degree (3+2 year course) or an equivalent certified foreign academic qualification for which is requested the recognition of equivalence by the Doctorate Academic Board, for admission purposes only. In the latter case, the applicant must attach a certificate listing examinations and marks achieved. In any case, applicant must indicate final grade, name of University, College or Institution and date of achievements.

Art. 3 – Application for Admission

Students from countries outside the European Union, who wish to apply for admission to a doctoral course, must submit by e-mail the attached application form (annex A3) duly filled in and all requested documents to doctoraleducation@unime.it not later than 30 days by the day after the date of publication of this announcement on the Italian Official Gazette.

At the same time the announcement will be available at <http://www.unime.it/ateneo/bandiconcorsi/dottorati.html> and on “Albo Ufficiale d’Ateneo” at <http://www.unime.it/ateneo/albo.php> (official University register).

Documents to be attached to the application (files in pdf):

1. a curriculum vitae, with details of any previous research experience, duly dated and signed;
2. a certificate of the academic qualification / university degree issued by the awarding University, listing examinations and marks achieved;
3. a list of scientific publications, if any;
4. two recommendation letters by University professors in Italy or abroad;
5. a photocopy of a valid identity document with photograph.

All documents must be in Italian or English, or accompanied by a translation in Italian or English.

Art 4 - Examining Commission

Applications will be evaluated by a Committee appointed by the Senato Accademico of the University of Messina.

Art. 5 – Acceptance and Admission to the Course

A handwritten signature in black ink, likely belonging to the responsible authority, is placed here. A small number '2' is written to the right of the signature.

The results of the evaluation will be disclosed in due time at www.unime.it/ateneo/bandoconcorsi/dottorati.html as "Results /Final List".

No notification of the selection outcome will be sent to the applicants. Candidates successfully positioned in the final list will receive a communication by e-mail. They must send their acceptance to University by e-mail to doctoraleducation@unime.it with a scanned copy of a valid ID document (pdf). The acceptance must be received not later than 10 days from publication of the list on the University website. If the acceptance is not received by University by the date indicated, the winner will be excluded from the list.

Art. 6 – Enrolment

The winners, who have already communicated their acceptance as per art. 5, must complete their enrolment at their arrival in Italy. They must hand over the following documents to Università degli Studi di Messina - Alta Formazione, Dottorati per cittadini stranieri perfezionamento e borse, Via Consolato del Mare 41, second floor, Messina, Italy:

- a) enrolment form which will be available on the University website at link <http://www.unime.it/ateneo/bandiconcorsi/dottorati.html>;
- b) original certificate of the University qualification obtained abroad or equivalent, with translation into Italian certified by the competent Italian Embassy or Italian Consular Office;
- c) "Dichiarazione di valore in loco", an official document providing all the details of the academic career of the candidate, issued by the competent Italian Embassy or Italian Consular Office of the country where the qualification was awarded, and its certified translation in Italian;
- d) the Stay Permit issued by the Italian local police station (Questura). All details and procedures can be found on the web site of the Ministry of Foreign Affairs (<http://www.esteri.it/visti/>);
- e) photocopy of a valid identity document;
- f) a passport photo.

Doctoral students must also hand over to the University of Messina within than 10 days from enrolment:

1. Italian tax code;
2. health insurance and social security (doctoral students should open an INPS account filling out a "Gestione separata dei Lavoratori Autonomi" form available at any INPS office in Italy - Italian social security institution).

Art 7 – General Rules

Doctoral students undertake to attend the doctoral course full-time, according to the provisions of the Doctorate Academic Board.

Doctoral scholarships are paid in two-monthly instalments. Every two months, the Coordinator of doctoral course certifies student attendance to the course. This is necessary to the payment of the scholarship.

At the end of every year, each student shall submit a report of the activities carried out.

Art. 8 - Conferment of Qualification

The qualification is obtained by completing the course and passing the final examination.

Art. 9 – Personal Data Protection

Personal data supplied by candidates will be collected by the University of Messina and handled for selection and career procedures – as per Legislative Decree/executive Order (D.Lgvo) 196/2003.




